Has obtained **EC TYPE EXAMINATION INSPECTION CERTIFICATION**, in compliance with what is stated in Directive 89/686/EEC and in agreement with the applicable test procedures according to standards *UNE-EN 340:2004* and *EN ISO 13688:2013* general requirements, *EN ISO 11612:2015* against thermal risks of limited flame spread (A1 and A2), convective heat (B1), radiant heat (C1) and contact heat (F1) and *UNE-EN 1149-5:2008* against the risk of accumulation of electrostatic loads according the standard *UNE-EN 1149-3:2004*, having attained the levels of provision specified in **TEST TECHNICAL REPORT N°2016EP1244CE** and in **PPE'S TECHNICAL DOCUMENTATION**.

PPE DESCRIPTION:

A long-sleeved garment made in navy blue pique knit, comprising front and rear assemblies, sleeves and a collar. The front assembly is single piece and is joined at the shoulders to the rear assembly, to the collar at the neckline and to the sleeves at the armholes. The throat and neck are open from the base of the collar with a 140 mm-long opening, fastened by three navy blue acetate buttons sewn to the right-hand side with corresponding buttonholes on the left. On the left-hand breast is a white embroidered logo reading "Polisan HOLDING". The rear assembly is a single piece, joined to the front assembly at the shoulder a side seams. In the centre of the back is a white embroidered logo reading "Polisan HOLDING". On the inside left-hand seam are garment information labels provided by the manufacturer. The long sleeves are each made from a single piece and end in a cuff made from a double layer of navy blue knitted fabric, measuring 50 mm in width. The collar is shirt type and made from a single piece of knitted fabric joined by a double seam to the front and rear assemblies. The three central buttons described above adjust the collar opening. A 5 cm-wide yellow-grey-yellow band of reflective tape is applied around each sleeve and at the shoulders, 11cm at the front and 11cm at the back. The shirt ends in an interior double-backstitched hem.

The materials that form the PPE, are described in the test technical report n° 2016EP1453CE.
